#### TAXATION, DUTY, CUSTOMS AND PAYMENTS RELATED INFORMATION

- 1.10 Taxes on Imported Materials, the Supplier/service provider/contractor will have to pay all taxes payable as applicable for all materials to be supplied unless the item(s) is/are donor funded or otherwise exempted from tax.
- 1.11 Customs Clearance: The contractors shall be responsible for custom clearance of their imported goods and materials.
- 1.12 Contract Price The contract shall be of unit price type or cumulative of computed unit price and quantities required. Prices quoted should be inclusive of all delivery charges.

1.13 Payments of All local purchase orders shall be on credit of a minimum of thirty(30) Days or as may be stipulated in the Contract Agreement.

# REGISTRATION/REGISTERED DATA INSTRUCTIONS

2.1 Registration data forms the attached questionnaire forms PQ-1, PQ-2, PQ-3, PQ-4, PQ-5, PQ-6, PQ-7, PQ-8, PQ-9 & PQ-10 are to be completed by interested suppliers/contractors

- 2.2 The registered application forms which are not filled out completely and submitted in the prescribed manner will not be considered. All the documents that form part of the proposal must be written in English and in ink.
- 2.3 Qualification
- 2.4 It is understood and agreed that the registration/Prequalification data on prospective bidders is to be used by the hospital in determining, according to its sole judgment and discretion, the qualifications of prospective bidders to perform in respect to the Tender Category as described by the client.

Prospective bidders will not be considered qualified unless in the judgment of the hospital they possess capability, experience, qualified personnel available and suitability of equipment and net current assets or working capital sufficient to satisfactorily execute the contract for goods, work and services.

2.5 Essential Criteria for Registration/Registered

2.5.1 Experience: Prospective bidders shall have experience in the supply of goods, works services and allied items. The potential supplier/contractor should show competence, willingness and capacity to service the contract at short notice.

2.5.2 Personnel .The names and pertinent information and CV of the key personnel for individual or group to execute the contract must be indicated in form PQ-3.

2.5.3 Financial Condition. The Supplier's financial condition will be determined by latest financial statement submitted with the REGISTRATION documents as well as letters of reference from their bankers regarding suppliers/contractors credit position. Potential suppliers/contractors will be registered on the satisfactory information given.

2.5.4 Special consideration will be given to the financial resources available as working capital, taking into account the amount of uncompleted orders on contract and now in progress data on Form PQ-4. However, potential bidders should provide evidence of financial capability to execute the contract.

2.5.5 Past performance will be given due consideration in registering bidders. Letter of reference and or copies of order/contracts from past customers should be included in Form PQ-6

#### 2.6 Statement

Application must include a sworn statement Form PQ-8 by the tenderer ensuring the accuracy of the information given.

- 2.7 Withdrawal of REGISTRATION Should a condition arise between the time the firm is registered to bid and the bid opening date which in the opinion of the client/hospital could substantially change the performance and qualification of the bidder or his ability to perform such as but not limited to bankruptcy, change in ownership or new commitments, the hospital reserves the right to reject the tender from such bidder even though they were initially registered
- 2.8 The firm must have a fixed Business Premise and must be registered in Kenya, with Certificate of Registration of Registration/Incorporation/Memorandum and Article of Association, copies of which must be attached.
- 2.9 The firm must show proof that it has paid all its statutory obligations and have current Tax Compliance Certificate which is mandatory.

#### CRITERIA FOR REGISTRATION

Meru teaching and referral hospital will apply the following criteria when assessing the applications for registration. Only applicants who qualify to meet the mandatory, technical and financial requirements subsequently will be subjected to the registration application documents elements, which is a check list and award system:

#### 3.2 Information used to assess applicant

MeTRH will use the information provided by the applicant in this registration application document to reach a decision, but reserves the right to ask for further information from any or all of the applicants as well as from the references provided as proof.

# 3.3 Preliminary Evaluation Criteria for Registration

To register, all applicants <u>MUST</u> meet the following mandatory requirements for preliminary evaluation:

- 1. Submit a copy of Certificate of Registration/ Incorporation from the registrar of companies/ businesses as either Limited Company, partnership or sole proprietorship;
- 2. Satisfy all the Kenya Revenue Authority requirements and show proof by way of providing Valid Tax Compliance Certificate;
- 3. Submit copy of a valid trading license covering the supply of the goods, services or works applied for under the relevant category;
- 4. Copy of license certificate for registration by N.C.A (National Construction Authority in the relevant field) for the following categories:
- a) Registration of building contractors
- b) Contractors for minor building and civil works
- 5. In Accordance to the Public Procurement and Asset Disposal Act 2015, MeTRH shall reserve categories indicated ONLY for the youth, women and persons with disability30% as a matter of preference to their small and micro enterprises. Consequently this group MUST, above meeting other preliminary requirements, provide <u>certified</u> copies of registration with relevant authority (s) for Access to Government Procurement Opportunities (AGPO) before proceeding to the technical and financial evaluation stages.
- 6. Fully Completed Forms PQ 1- PQ 10 as provided in this registration document.

# 4.6 Current and Future Status of the Applicant

MeTRH recognizes that the information presented in this Registration Application Document represents the status as at the point of application, and that this may change in the course of the year.
